

**ORDER**

As per the Order read 2nd paper above, NOC had been issued to Marymatha Public School, Lalam, Kottayam, subject to the execution of agreement in the prescribed format. As per the Order read 3rd paper above, Govt. issued guidelines for Recognition, under the Right of Children to Free and Compulsory Education Act, 2009 and issuance of NOC for CBSE/ICSE affiliation of schools.

2. The Director of General Education, Thiruvananthapuram, as per the letter read above forwarded the proposal of Marymatha Public School for Recognition, for affiliation to CBSE. He reported that NOC had been issued to this School, on condition that school building will be re-constructed in Survey No.58/55, due to the shortage of land. Since no permission has been obtained from the Municipality to construct the School building in Survey No.58/55, they have constructed the school building in Survey No.171/12 at Kannadiyurumpu, Pala. Hence it is requested to modify the Order read 2nd paper by changing the name of the school from Marymatha Public School, Lalam, Kottayam to Marymatha Public School, Pala, Kottayam, Pin - 686575.

3. Government have examined the proposal with reference to the



details/documents enclosed with and sanction is accorded to change the name of the School "Marymatha Public School, Lalam, Kottayam" as "Marymatha Public School, Pala, Kottayam, Pin - 686 575" and granted Recognition to Marymatha Public School, Pala, Kottayam, Pin - 686 575 for affiliation to CBSE, under the Right of Children to Free and Compulsory Education Act, 2009.

4. Government Order read 2nd paper will remain in force with the above amendment.
